



I am directed to forward herewith a copy of Guidelines issued by Ministry of Health and Family Welfare for allocation of Central Pool MBBS/BDS seats for **spouse and children of civilian victims of terrorist** for the academic year 2021-22. Eligibility criteria for selection of the candidates for the above allocation is mentioned at **para 3 (iii), 3.1 to 3.3** of the guidelines.

2. It is intimated that this Ministry is not conducting any examination in this regard, the selection will be made only on the basis of marks obtained by the students in NEET-UG 2021 and possessing necessary educational qualification.

3. It is requested that the State Government (s) / Union Territory Administration (s) may kindly give wide publicity while inviting application (s) from eligible candidates as indicated above for the academic year 2021-22 for allocation of MBBS/BDS seats from Central Pool for spouse and children of terrorist victims. **It may be ensured that complete application (s) of eligible candidates, in the enclosed prescribed format (Annexure-I), in duplicate enclosing all necessary documents in respect of their States/UTs are received alongwith due verification/authentication and countersignatures of the Competent Authority.**


